10. Each tenderer must enclose along with his/her tender a certificate of solvency signed by the Tahsildar of the Taluk in which tenderer owns the immovable property. II. TENDER SPECIFICATIONS:

- 1. The rates should be quoted in whole Rupee and Paise only per Kg / No of feed
- 2. The rates quoted should be inclusive of all taxes and delivery charges inclusive of all incidental charges such as loading, unloading, packing, forwarding, Insurance and stocking charges etc.
- 3. The supply should be made at the supplier's own risk
- 4. Rates should be quoted for each of the feeds with relevant EMD. Otherwise, the tender will be disqualified
- 5. The rates quoted should be valid for a period from the date of agreement execution to Six Months
- 6. No representation towards the upward revision of rates will be entertained. Rates once accepted will be final, ex-godown rates offered by the firm are not acceptable and such tenders will be summarily rejected. The rates should be quoted for delivery as specified by the WILDLIFE WARDEN, CHENNAI WILDLIFE DIVISION
- 7. No increase in the rate will be allowed during the period of the contract or on extension period under any circumstances

III. <u>GROUNDS FOR REJECTION OF TENDER APPLICATION:</u>

- a. Tenders should be submitted only through online, Hard copies will not be accepted.
- b. Scanned copies of all supportive documents placed with tender, should be clear and readable, otherwise it will not be considered. If the required certificates are in the language other than Tamil or English, self-attested copy of English version should be placed for verification and record otherwise, the particular document will be treated as not submitted.

- (iii)AND THAT, the parties agree that any dispute or difference whatsoever arising between the parties out of/ under or in connection with or relating to the construction, meaning, scope, operation, or effect of the contract or the validity or the breach thereof shall be referred to a sole Arbitrator as appointed under clause
- (iv)(VI) herein below, and that the award made in pursuance thereof shall be binding on the parties.

- b. Provided that before requesting the Principal Chief Conservator of Forests and Chief Wildlife Warden, Chennai – 32, for appointing an Arbitrator, the parties shall make a sincere attempt to resolve their dispute, with a time period of 3months, through mutual
- c. conciliation, and if so felt necessary by the parties under the supervisory guidance of the Principal Chief Conservator of Forests and Chief Wildlife Warden, Chennai 32;

(vii) AND THAT, all costs relating to the Arbitration proceedings, shall be borne equally by both the parties;

- (I) AND THAT, the parties agree that the language for making all submissions and evidence will be presented in ENGLISH during the proceedings;
- (II) AND THAT, it is agreed between the parties that they shall extend their fullest support and co-operation to the Sole Arbitrator and not seek adjournment of the Arbitration proceedings, without explaining the reasons therefore, in writing, in advance, for seeking of such adjournment, and further that there shall not be more than two such adjournments granted even when there exists a valid reason for seeking such adjournment. And it is further agreed that the parties should cooperate in completing the arbitration process and the broader dispute resolution with 6 months or at most with an extension, on mutual consent, of another 6 months
- (III) AND THAT, it is agreed by the parties hereto that, in so far as there is an arbitral award for payment of money, the Sole Arbitrator may include in the sum for which the award is made, interest at the RBI repo rate, as on the date on which the cause of action arose, plus 2%, on the whole, or any part of the money, for the whole or any part of the period,

between the date on which the cause of action arose and the date on which the award is made;

- (IV) Provided that, on the sum so directed to be paid by an arbitral award, there shall be no interest payable for three months commencing from the date of award, but thereafter, interest shall be payable at RBI repo rate plus 4% for such period of delay, till the date of payment
- (V) The Arbitrator shall record, in writing, the arguments of the two parties on each of the points of dispute and pass a speaking order thereon
- (VI) AND THAT, in so far as Arbitration is concerned, the terms and conditions of this supplementary Arbitration Agreement shall prevail over anything to the contrary that may be spelt out in main contract as referred to in clause (I) above
